Re: "Dear Friends" Letter:

Ms. Lewen: Hello...

Greetings to you; and Special THANKS for the package. That's a bit of human compassion not often seen or, experienced here. Yet, sorely needed.

I'm not alone in a shared experience, but that does not make it normal. As an Arkansan under Unconstitutional Seizure, and held under False Imprisonment for almost eleven (11) years, my focus is NEVER off gaining liberty. Even without these walls, many experience "communism" having let the media paint rosey pictures doesn't make it less emphatic or definitive. Communism was not imported here by Karl Marx; it was EXPORTED from here to the rest of the New World. Robert Owen and Charles Fourier were simply left from our exposure to history via the views chosen by Simon and Schuster.

Ms. Lewen, I'm a currency trader; in 2006 - 2007, I averaged \$60,000.00 to \$80,000.00 monthly, net, by "shorting the market. For what its worth, I gave up the clear average to venture into the speculative "FOREX"; go figure. However, I eventually, returned to SPOT-BUYING, and excelled indeed.

In late 2007, associates began to beg for help with their mortgage turbulence. What we could not have known then, is J.P. Morgan Chase, had shifted the numbers that controlled the variation on the market, causing regular contract-lease holders (buyers) to falter; some to fail. Then... shortly after, Jaime Dimon, himself, shorted the market... and committed outright fraud on MILLIONS of homeowners. He subdued the market... and pled GUILTY in court to untold thefts and conspiracy(ies).

To provide remedies, I opted to present edited seminars, mainly to Caucasian audiences; as they had more comprehensive English control; resulting in less repetitiveness. There was so much backlash, that eventually, I opened my events to others. Blacks, Hispanics, Filipinos attended in thousands... which caused rapid expansion... and entrusting independent contractors.

As a faction, we began to take-in \$2,000,000.00 per group; and there were five (5) groups, loosely bound and haphazardly reporting to each other. I made a point of not handling the monies from all but one (1) group. It kept the trust issues sane, and limited the subject matters discussed.

Not surprisingly, copycat groups began to appear under my group-name: LARRY SMITH FINNANCIAL SERVICES (L.S.F.G.) As a nontaxpayer, and private person, I quickly cancelled my social security number, driver's license (which had been surrendered to the Dept. Of Motor Vehicles in 2005, and lived my life.

Page 2:

In late 2007, I began to notice there were challengers attending these events that openly critized my revelations to "foreignere". Some referred to such a "Sovereign Studies"; showing an ignorance in land laws. I began to make it a point to open the event with the illustration of what home ownership is today, versus what the Jaimie Dimons are pushing on "consumers" with little or no historical knowledge of land buying, or security.

After the spring of 2008, and careful definitions of "sovereignty", versus "subject" began to dominate, I contracted-out the presenter roles, quite frequently. In attendance, had always been veterans, district attorneys, attorneys, independent announcers, contractors, laborers, restaurant owners, politicians, chefs, clerks... a broad array of our society.

In late July, several contracting parties complained that their NOTICES to the various counties recorders were blocked; thereby causing their security interest claims to fail. After which, their mailed-in Calif. U.C.C.'s were rejected. We discovered the San Diego District Attorney, Bonnie Dumanis had directly, or through her prosecutor, Marlene Coyne, had blocked these owners NOTICES. And, that said blocks caused failed reportings of changes in security reportings, Deeds of Trusts, and most of all, security interest transfers into land for claim support.

I thereafter discovered that district attorney investigator, Alex García had actually shown photographs to multiple clients of LARRY SMITH. Most appear to be "MUG SHOTS; along with statements by these agents to such clients.

This went on for months ... hundreds of people reported this to me. So many that I phoned the district attorneys office for explanations. Their only response was: "You Will Soon Find Out!"

Upon return from the Philippine Islands, <u>December 25, 2008</u>, I was Unlawfully arrested for the second time. I want the first arrest to STAND-OUT:

On, November 25, 2008, I returned to San Bernardino from New York to debrief. Feeling sore from the two lengthy flights, I sought to soak in an associates hottub within hours of my return.

Ironically, he met me in front of his home, requesting a ride to a waiting client of his, prior to my soak. As it turned-out, he had been engaging in duplicity of the LSFG products; but... with no follow-through.

At the location, the client expressed what he had done in my presence. Both the associates and the client apologized to me, that L.S.F.G. products were used without my knowledge. The sherrifs were called. They were understanding, initially, but arrested me along with the associate; then commenced to search my Mercedes without a warrant... even though it was legally-parked, and secure. The engine was OFF!

Page 3:

During that search, the sheriffs then carted me to an awaiting cruiser and removed my outer clothing, and began to search my pants as I stood. He then became more deliberate in his search; and asked: "Where's the remote?" Meaning, the device that electronically opens the Mercedes.

I said, "I Do Not Consent to a search."

With that, deputy, Souza punched me in the solar plexus area. I doubledover in agony. He then shoved me into the backseat of the cruiser. I leaned forward impulsively, to vomit. He continued to search, until locating the remote device in my back pocket.

He and his partner approached the Mercedes and activated the remote to open the locked trunk. They then proceeded to rummage through my private property, and removed a burgundy briefcase bearing combination locking hinges on either side.

They, together, removed the 'locked briefcase to the trunk-lid of their sheriff cruiser, and used letter opener type probes to break the locks and proceeded to search among the private data.

From this UNlawful Seizure, and False Imprisonment, the Fontana sheriffs secured the location of my primary land location, and obtained an invalid SEARCH WARRANT, December 04, 2008. EVERYTHING USED TO EFFECT THE ARREST December 25th. 2008, resulted from the UNlawful, Unconstitutional Seizure committed, November 25th. 2008.

That arrest, AND UNCONSTITUTIONAL SEIZURE WAS COVERED-UP BY THE SENTENCING MAGISTRATE, PROSECUTOR, DEFENSE COUNSEL, and the DISTRICT ATTORNEY'S IN-VESTIGATOR, Alex Garcia. I suffered seven (7) beatings for persisting in presenting it on record. It has since been erased; or simply not produced. The evidence for the above is IN my possession

C.D.C.R. is a multi-TRILLION DOLLAR INDUSTRIAL COMPLEX. Its 'intereste are not mere economical and industrial, but are 'racial' and 'political' Men sentenced to C.D.C.R. lose their Right to procreate, and to care for those was a full commitments. These interests are Unalienable.

Upon arrival, my "NONviolent offense has been colored "VIOLENT" by program administrators and counselors. And, correctional officers follow with the necessary disciplinary citations to justify HIGHER classification than would suit a NONviolent offender.

Every prisoner with a social security number is valued at \$3,500,000,000 Public Law 108 - 458, enqbles one to have ten (10) replacement cards per lifetime; that's eleven (11) cards. \$38,500,000,000.00 (Billion)
In addition, C.D.C.R. uses our Unified Tax Credits (\$5,500,000.00) Mil. and the California governors donate \$300,000.00 per prisoner, annually.

At 160,000 prisoners... do the math. Retaining those that have 20, 30, an more years... the interest alone is SIGNIFICANT!

What's even MORE SIGNIFICANT, Ms. Lewen... remember the gentrification of Oakland, a while back? Well prisoners are mortgaged, too. Each one of us leaves money (credit/debt) on the books when we parole. In fact, we are classified as "subcontractors under the various wardens.

Were our beneficiary (ies) to file 2943's upon our leave of prison, all of the monies expended via our "Estates" may be recovered... in the interest... directly, or via the Treasary of the United States. We most often, leave that on the books. There IS NO MORE*(\$) Money, Ma'am. We are lulled into being "DEBTORS" for King Congress, at the expense of our lives, youth, and health... often for peanutes.



Page 5:

"There Is NO Criminal Law In California; the 'Common Law' is the Rule of decisions in ALL Courts in this state. People v. Vasilyan, (2009)

San Quentin is a construct from the expressed designs of James Gadsden, a slaver, who with Issac Edwards Holmes, and William Jefferson Green, composed the draft presented by Gadsden to the California Senate and Assembly, in 1851. The apartheid governor, Peter Burnett, who's name you will not easily find listed as the state's first governor, supported.

It (San Quentin) is a "kennel", Ms. Lewen, to any who has to live here. Its S. Q. proximity to humans that both give us the substance to endure this unearthly confinement in such small spaces. But... admission or not, long term stay has permanent consequences to every human's psychic.

While here, I bill for any order, instruction not directly connected to safety and, or security. All else is a breach of one's fiduciary duty, in my case the, LARRY SMITH, Estate. And, that's my property for control purposes, while I live.

FINALLY ... Here Are The Authorities Supporting My Actions:

First: Calif. Civil Code 22.2: "The Common Law of England, so long as its not repugnant to the Constitutions of the United States and the State of California."

Next: MAXIM: "Liberty is more favored than all things.

Com. Law: "Theft is not in its nature, a 'breach of the peace."
Radloff v. National Food Stores, 20 Wis. 2d 224;

Finally, "When a peace officer exceeds his authority... he becomes a trespasser, and he is liable for false imprisonment, and related injuries sustained."

Muscoe v. Commonwealth, W. Virginia 443, 10 S.E. 534.

The Superior Court is not a Constitutional Court. Its jurisdiction is limited to that of its actors, or the territories of the United States. American Insurance Co. v. 356 Bales of Cotton.

Ms. Lewen, "We are a nation of laws... not of men." With that knowledge it is incumbent upon all of us to study and know not just what the law IS, but as well, what the law is <u>not</u>. If one pleads in any court, to an invalid law, s/he validates that law; making it applicable to him, when it otherwise, would have been inapplicable.

Acts of Congress are ONLY enforceable in the District of Columbia. Unfortunately, many attorneys 'plead-us' into courts' jurisdictions even before we are otherwise susceptible to that court's authority. Attorneys are not lawyers.

Page 6:

During my stay in the Philippines Islands, I passed a clothing store that featured a television in the display window. A News flash repeated, showing a brief clip of my California's driver's license photo.

Being but one of 10,000 in the area, and the only Black, all eyes stared at me. The store owner hesitated as I entered. Being in the company of the Mayor of Tacloban, and his family. The San Diego district attorney had advertised my driver's license as though it was current. Fully realizing I had cancelled it several years, consecutively, since 2003.

In addition the district attorney's investigator published my former social security number, as to cause those to whom said instruments were published would perceive me as a United States citizen (debtor), on-the-run. Simultaneously, the \$142,000.00 U.S.D. bail, was raised to \$3,000,000.00; more than 30,000 percent HIGHER than the \$10,000.00 that was provided when I left for the Philippine Islands.

There were in excess of \$300,000.00 USD in my land safes prior to my leave. The searching officers flatly stole \$188,000.00; then turned-in \$97,750.00 of which there are bank receipts from currency trades, and spot-buys done in New York, Africa, Mexico, and the Philippines.

Remarkably, the district attorney confessed the reason for confiscation was to deprive me of the Right to exercise the Sixth Amendment GUARANTEE of the Right To Access To Counsel Of My Choice. Even as the trial proceeded under my take-over, the San Diego court rejected me Right to standby counsel as provided by Superior Court Rule 8:43. Simply put... when I complained I was either beaten, punched, elbowed, or my property was conveniently disposed of, permanently.

One deputy saved me from numerous attempts by others; his name is Pete. Pete is MY father's nickname. Pete retrieved me upon arrival to the San Diego court, and personally escorted me to Dept. 38, safely.

One Filipina woman... of hundreds that I knew, protected me by reliably attended my trial process, daily. Brenda Bidaure. But for Brenda, I now would be facing 125-Years-To-Life! She was also a direct witness to several beatings. As were other prisoners and onlookers.

When the S.Q.S.P. administrators fraudulently color my conviction as 'violent', intentionally and fraudulently misrepresenting the facts, it strengthens my resolve to find someone with the ovaries or balls to STOP this run away train. I NEVER lose or lessen hope.
