



I'm also in the prison college program - well at this time, I'm not in a class - I'm in Coastline Community College - I have one more class to finish my Associate of Arts degree in Social and Behavioral Science, and Associate of Science in Business - I only have to pass Algebra-8301. I have to basically study and learn this on my own, because we don't have tutors on death row —

I'm from Oakland, Calif - I've been held captive for 32 years for robbery murder based on circumstantial evidence - At this time, I'm waiting on a ruling on my
